1. Board President Vonda Halford called the meeting to order. All board members were present.
2. Mrs. Poole, Elementary Principal reported on the following activities: There were 384 in attendance of the grandparents day breakfast recently; the current elementary student enrollment is 609; Mrs. Turner, Middle School Principal reported on the following MS activities: Between the MS Student Council and MS Service Club they were able to purchase angel tree gifts for 25 kids this year. Ms. Barker is sponsor of the Student Council and Darin Marin is sponsor of the Service Club. An Internet Safety Night will be held December 13.
